

Broadcast Agreement

BROADCAST AGREEMENT BETWEEN CD SYNDICATIONS INC. AND BROADCASTER

The broadcaster agrees to air the series *Center Stage from Wolf Trap* under the following guidelines and restrictions:

1. For the right to broadcast, the station agrees to air each radio program (supplied on compact disc or other medium) without alteration, cutting or editing, except for alternate program cues as specifically allowed by CD Syndications. Broadcaster may insert local station breaks and announcements at times specified on the cue sheet of each program.
2. Broadcaster is allowed one release of each program within twelve months of the series initiation date (January 1, 2008). A release is defined as an unlimited number of plays within one week of the first play. The broadcaster may air the programs in series order at anytime within the twelve month release window.
3. In accepting the programs, the broadcaster has the right of use on the station's broadcasting facilities and network.
4. Broadcaster acknowledges that this agreement is a subscription to the right of broadcast. It is not the purchase of the program. The program's contents remain the property of CD Syndications and the Wolf Trap Foundation.
5. The broadcaster agrees that the compact discs or tapes upon which these programs are delivered remain the property of CD Syndications and the Wolf Trap Foundation. Following the broadcast period, all compact discs or tapes are to be returned to CD Syndications. They will be recycled. The following year's programs will be made available to the broadcaster once the previous year's programs have been returned to CD Syndications.
6. Material furnished is for broadcast only and may be used for no other purpose. Broadcaster agrees not to transfer the contents of any program to any media for use in any commercial product, or for use in any device for the home, or for use in any way other than as specifically allowed by this agreement.

To subscribe to *Center Stage from Wolf Trap*, fill out the form on the back of this booklet and fax or mail it to CD Syndications. Your Signature on the form indicates your acceptance of the above broadcast terms. Upon receipt of your subscription, programs will be mailed to your station approximately one month prior to broadcast.

This program is provided free of charge to radio stations! However, we do request the following:

1. Please uphold all terms put forth by the Broadcast Agreement.
2. Please do not begin broadcast of this series prior to January 1, 2008.
3. Please sign and return the broadcast affidavit indicating exactly when the series will be broadcast.
4. Please return the program discs. The discs will be re-used or recycled.
5. Please let us know how we can improve the program and our service to you!

Our station agrees to the terms of the CD Syndications Broadcast Agreement and will abide by this agreement in broadcasting *Center Stage from Wolf Trap*.
